



June 12, 2014

1. Mayor Eric Selby called the meeting to order.
2. **Ricky Barnes made the motion to accept the May 8 minutes. David Blakey seconded the motion. Motion carried 5-0.**
3. **Eddie Thomas made the motion to pay the bills. Timmy Hudson seconded the motion. Motion carried 5-0.**
4. The Council heard the 2nd reading of Amended Budget Ordinance 2014-04. **Timmy Hudson made the motion to accept Amended Budget Ordinance 2014-04. David Blakey seconded the motion. Roll call vote with Mr. Barnes-yes; Mr. Robertson-yes; Mr. Hudson-yes; Mr. Thomas-yes; Mr. Blakey-yes. Motion carried 5-0.**
5. **Joshua Robertson made the motion to accept Paul Combs Agreement. Timmy Hudson seconded the motion. Motion carried 5-0.**
6. **David Blakey made the motion to accept Interlocal Road Agreement with the Magisterial District 5. Eddie Thomas seconded the motion. Motion carried 5-0.**
7. The Council was presented Municipal Road Aid Resolution 2014-02 from the Transportation Department. **David Blakey made the motion to accept Municipal Road Aid Resolution 2014-02. Ricky Barnes seconded the motion. Roll call vote with Mr. Thomas-yes; Mr. Blakey-yes; Mr. Hudson-yes; Mr. Barnes-yes; Mr. Robertson-yes. Motion carried 5-0.**
8. Ms. Sandy Edmonds asked this question: Businesses or property owners who don't live in the City Limits, but pay taxes, don't get to vote, don't get to run for public office, is this considered taxation without representation and if so, what can be done about this? Mayor Selby stated there is a KRS concerning this; will not allow any person other than a resident of the City to run for public office and he would get her a copy.
9. **Ricky Barnes made the motion pursuant to KRS 61.810 1 (b) at 6:20 p.m. to enter into executive session for deliberations on the future acquisition or sale of real property by a public agency. Eddie Thomas seconded the motion. Motion carried 5-0.**
10. **Joshua Robertson made the motion to reconvene at 6:36 from executive session with no action taken. Timmy Hudson seconded the motion. Motion carried 5-0.**
11. **David Blakey made the motion to adjourn. Eddie Thomas seconded the motion. Motion carried 5-0.**
