- 2. Eddie Thomas made the motion to accept the November 19 minutes. David Blakey seconded the motion. Motion carried 6-0.
- 3. Ricky Barnes made the motion to pay the bills. Tommy Holt seconded the motion. Motion carried 6-0.
- 4. Mayor Selby informed the Council the Christmas Parade had 92 entries. Everyone pleased with the Christmas Parade, excellent help, weather was great, positive comments.
- 5. Mayor Selby presented playground equipment for ages 2-5 years. Grant has been declined, City will pay for the playground equipment, then if grant money is received later, an additional piece of equipment would be purchased. Ground work will be an extra expense, black rubber mats may be used inside the fence for ground coverage. Sherry Daniel made the motion to purchase two (2) pieces of playground equipment for a total of \$9,767.00. David Blakey seconded the motion. Motion carried 6-0.
- 6. Tony Brummett-Spokesperson for Revive Russell, Thanked the Mayor and Council; a plan for a brighter future and a safer place to raise our families through economic development and tourism.
