## Interim Settlement Proposal

RE: Jamestown – Russell Springs Sewer Billing Dispute

- 1. Effective with the date this Interim Settlement Proposal is approved by the Jamestown City Council and continuing through June 30, 2016, Russell Springs will pay Jamestown for an assumed (estimated) sewer flow of 15,000,000 gallons per month times \$3.45 per 1,000 gallons (15,000 x \$3.45 = \$51,750).
- 2. Russell Springs will be credited for all sewer payments it has already made for these billing periods.
- 3. Once the new flow meter is installed by Russell Springs, calibrated, and is accurately measuring the sewer flow to the satisfaction of both Parties, the Parties may elect to start using the actual flow volume rather than using the estimated 15,000,000 gallons.
- 4. The issue of the outstanding balance allegedly owed by Russell Springs, which Russell Springs denies owing, is left unresolved at this time.
- 5. The Parties agree to continue negotiating in good faith to resolve all other outstanding issues.
- 6. Neither Party waives any of its rights under the Wastewater Treatment Contract dated April 29, 1994.
- 7. Each Party reserves any and all legal defenses it may have.
