


April 9, 2015

The Russell Springs City Council held their regular monthly meeting this date at City Hall at 6:00 p.m. In attendance were Ramie Hutchison, Beth Fox, Mike Scales, Frank Irvin, Jacob Irvin, Ronald Burton, Joe Irvin, David Blakey, Sherry Daniel, Ricky Barnes, Tommy Holt, Timmy Hudson, Eddie Thomas, Eric Selby and Wendy Burton.

Prayer was said by Timmy Hudson.

1. Mayor Eric Selby called the meeting to order.
2. **David Blakey made the motion to accept the March 12 minutes. Ricky Barnes seconded the motion. Motion carried 6-0.**
3. **Sherry Daniel made the motion to pay the bills. Tommy Holt seconded the motion. Motion carried 6-0.**
4. Mayor Selby informed the Council necessary paper work is being completed to apply for a grant through Land and Water Conservation Fund Act for new playground equipment. David Blakey suggested to everyone to look at the playground by the Headstart building. Move forward with or without grant money. Sherry Daniel said she was very impressed with Park; more secure, working on a fenced in "City Dog Bark-Park area", community garden, heirloom flower beds.
5. Three bids were received on a 2015 Chevy Silverado for the Utility Department and the lowest bid of \$26,554.00 was received from Tincher Williams Chevrolet in London, Kentucky. **David Blakey made the motion to transfer \$26,554.00 to the Water and Sewer Department from the Kentucky Utilities monies. Tommy Holt seconded the motion. Roll call vote with David Blakey-yes; Tommy Holt-yes; Sherry Daniel-yes; Timmy Hudson-no; Ricky Barnes-yes; Eddie Thomas-yes. Motion carried 5-1.**
6. Kevin Williams will perform another concert this year on May 9, 2015 at 6:00 p.m. at the First Baptist Church for the Russell County Resource Center. The goal for 2015 is \$25,000 and Mr. Williams does this concert free of charge.
7. On April 23 at 5:30 p.m. a Public hearing will be held at City Hall for a zone change for property on Dowell Road. Letters have been mailed to property owners on Dowell Road.
8. **Eddie Thomas made the motion to pay the Transamerica Accident Policy for RSVF. Sherry Daniel seconded the motion. Motion carried 6-0.**
9. Mr. Frank Irvin came before the Council to announce the new Veteran's Organization "Russell County HonorGuard". This Organization is dependent on the Community for Support. The services this organization provides are Military Funerals, filing claims, monetary donations, etc. Plans in the near future are to help soldiers suffering from P.T.S.D., other mental health conditions and wounded and disabled Veterans. **Eddie Thomas made the motion to donate \$2,000 to the Russell County HonorGuard. Sherry Daniel seconded the motion. Motion carried 6-0.**
10. **David Blakey made the motion to adjourn. Eddie Thomas seconded the motion. Motion carried 6-0.**
