


October 9, 2008

The Russell Springs City Commission held their regular monthly meeting this date at City Hall at 6:00 p.m. In attendance were Joey Hoover, Dan Woodruff, Claradon Wilson, Jeanne Hudson, Brittany Emerson, Raymie Hutchison, Tyler Wooldridge, Derek Aaron, Richard Roy, Kenny Keener, Myron Fisher, Jeff Reeder, Ricky Barnes, Joe Irvin, Ray Barrett, Wayne Gaskins, Richard Wooldridge, Timmy Hudson, Matthew DeHart, Don Byrom, Hollis DeHart and Wendy Burton.

1. Mayor Hollis DeHart called the meeting to order.
2. **Richard Wooldridge made the motion to rescind item # 5 on the September 11 minutes to return to original name of Lake Trail Landing. Ray Barrett seconded the motion. Motion carried 5-0.**
3. **Wayne Gaskins made the motion to accept the September 11 minutes. Richard Wooldridge seconded the motion. Motion carried 5-0.**
4. **Ray Barrett made the motion to pay the bills. Timmy Hudson seconded the motion. Motion carried 5-0.**
5. The Commission heard the 2<sup>nd</sup> reading of Ad Valorem Tax Ordinance 2008-08. **Wayne Gaskins made the motion to accept the Ad Valorem Tax Ordinance 2008-08 as written. Richard Wooldridge seconded the motion. Motion carried 5-0.**
6. Discussion regarding the Doughboy in Jamestown. The Doughboy represents young men from this county who lost their lives for our freedom. **Richard Wooldridge made the motion to give the Doughboy fund \$1,000 from the City of Russell Springs. Timmy Hudson seconded the motion. Motion carried 5-0.**
7. Myron Fisher and Kenny Keener with Baldwin and Associates presented the audit for FY ending 6/30/08. Mr. Fisher expressed appreciation of City Hall Staff during the audit and indicated several notes to the audit with planned implementations. Otherwise, Mr. Fisher stated the City is in good financial condition.
8. Mayor DeHart commented on the street lights; have met with road blocks with the State Department; now have verbal approval, just waiting on the paper trail. Mayor DeHart along with Ray Barrett are looking into purchasing a street sweeper with a vacuum for Main Street, Industrial Park and the new Industrial Park on French Valley Road; will continue over the next month to research the Internet for sweepers.
9. Trick or Treating on Halloween night is set for 5:00 p.m. until 8:00 p.m. The Downtown Revitalization Committee will meet Tuesday night to discuss Trunk or Treat on Main Street.
10. Jeff Reeder with American Legion expressed appreciation for the \$1,000 donation.
11. Timmy Hudson stated a few firefighters continuing training; few grass fires, continuing to mail letters regarding home cleanups. The Russell Springs Volunteer Fire Department will be at the Russell County Hospital

on October 18 during their Health Fair. Mr. Hudson stated appreciation for the veterans.

12. Richard Wooldridge informed the Commission several sewer complaints had been resolved. He also stated appreciation for our veterans.
13. Ray Barrett informed the Commission that Richards Drive would be resurfaced; also Selby Asphalt will be using liquid sealer to do minor repair on several city streets.
14. Wayne Gaskins stated fifteen candidates had been sent to Richmond with nine remaining to send for testing. After all candidates have been tested the interview process will start.
15. **Richard Wooldridge made the motion to adjourn. Wayne Gaskins seconded the motion. Motion carried 5-0.**
