



January 10, 2013

1. Mayor Hollis DeHart called the meeting to order.
2. **David Blakey made the motion to approve the December 13, 2012 minutes. Lisa Mann seconded the motion. Motion carried 6-0.**
3. **Timmy Hudson made the motion to pay the bills. Ricky Barnes seconded the motion. Motion carried 6-0.**
4. The Council heard the 2<sup>nd</sup> reading of Ordinance 2012-05 Franchise Ordinance for Furnishing and Selling Electricity. **David Blakey made the motion to accept Ordinance 2012-05. Lisa Mann seconded the motion. Motion carried 6-0.**
5. The Council heard the 2<sup>nd</sup> reading of Ordinance 2012-06 Ordinance Abolishing Personnel Policies and Procedures. **Eric Selby made the motion to accept Ordinance 2012-06. Eddie Thomas seconded the motion. Motion carried 6-0.**
6. The Council heard the reading of Municipal Order 2013-01 Adopting Personnel Policies and Procedures. **Timmy Hudson made the motion to approve Municipal Order 2013-01. David Blakey seconded the motion. Motion carried 6-0.**
7. Mayor Hollis DeHart reappointed H.M. Bottom for another 4 year term to the Natural Gas Board.
8. Mayor DeHart announced a Concert of Prayer sponsored by the Ministerial Association on January 20, 2013 at 6:00 p.m at the Judicial Center.
9. John Veigel and Brenda Hadley came before the Council introducing **America In Bloom**. It is a volunteer program, works with your local extension office, high school students, garden clubs, etc. Judges can be brought in to the City to make suggestions for improvements, to see before and after pictures. Deadline is February 28, 2013. Council tabled decision until February meeting.
