


January 14, 2010

The Russell Springs City Council held their regular monthly meeting this date at 6:00 p.m. at City Hall. In attendance were Jeanne Hudson, Claradon Wilson, Joey Hoover, John Thompson, Charles Gossett, Richard Roy, Elana Andrew, Joe Irvin, Ray Barrett, Lisa Mann, Ricky Barnes, Timmy Hudson, David Blakey, Eric Selby, Hollis DeHart and Wendy Burton.

1. Mayor Hollis DeHart called the meeting to order.
2. **David Blakey made the motion to accept the December 10 minutes. Lisa Mann seconded the motion. Motion carried 6-0.**
3. **Ricky Barnes made the motion to pay the bills. David Blakey seconded the motion. Motion carried 6-0.**
4. Resolution 2010-01 a Resolution of Agency transferring from Non-Hazardous to Hazardous Coverage. Mayor DeHart informed the Council Matthew Parrish-28 years old- former Captain in the Army had been hired as a Police Officer. Anyone hired after 9/01/08 would be non-hazardous through CERS. Every Agency must petition the CERS Board to become hazardous. **Ray Barrett made the motion to pass Resolution 2010-01. Timmy Hudson seconded the motion. Roll call vote with Timmy Hudson-aye, David Blakey-aye, Eric Selby-aye, Ray Barrett-aye, Lisa Mann-aye, Ricky Barnes-aye. Motion carried.**
5. Executive Order 2010-1 pertains to classifications and pay increase for the water system personnel. After receiving the first water operator certification, an employee would receive a 5% increase in pay. After receiving the second certification, an employee would receive a 3% increase in pay. The Utility Department currently has two who are certified in the 15,000 range. **Lisa Mann made the motion to accept Executive Order 2010-1. Eric Selby seconded the motion. Motion carried 6-0.**
6. Executive Order 2010-2 pertains to classifications and pay increase for the waste water personnel. After receiving the first waste water operator certification, an employee would receive a 5% increase in pay. After receiving the second certification an employee would receive a 3% increase in pay. **Ray Barrett made the motion to accept Executive Order 2010-2. Eric Selby seconded the motion. Motion carried 6-0.**
7. Municipal Order 2010-01 updates the Policies and Procedures by adding the word genetics to the Statement of Equal Opportunity. **Lisa Mann made the motion to accept Municipal Order 2010-01 and add the word genetics to the Statement of Equal Opportunity. Ricky Barnes seconded the motion. Motion carried 6-0.**
8. Ray Barrett commended the Police Department on a job well done during the Save-a- Lot incident and especially Assistant Chief Jamie Rogers. Mayor DeHart stated the same thing with all City employees. Timmy Hudson stated it was hard to find good help. Mayor DeHart stated

Matthew Parrish; the new Police Officer would be a great asset to the Police Department.

9. **Ray Barrett made the motion to adjourn. David Blakey seconded the motion. Motion carried 6-0.**
