



December 13, 2012

"Oath of Office was given by City Attorney Matthew DeHart to Eddie Thomas, Eric Selby, David Blakey and Lisa Mann.

1. Mayor Hollis DeHart called the meeting to order.
2. **David Blakey made the motion to accept the November 8 minutes. Lisa Mann seconded the motion. Motion carried 4-0.**
3. **David Blakey made the motion to accept the November 15 minutes. Eddie Thomas seconded the motion. Motion carried 4-0.**
4. **Lisa Mann made the motion to pay the bills. Eric Selby seconded the motion. Motion carried 4-0.**
5. Mayor DeHart reappointed Gene Vance Smith to the Industrial Development Authority Board.
6. The Council heard the 1st reading of Ordinance 2012-05 Franchise Ordinance for furnishing and selling electricity. This occurs every 20 years.
7. The Council heard the 1st reading of Ordinance 2012-06 Ordinance abolishing Personnel Policies and Procedures.
8. Several homeowners came before the Council regarding the speed bump on Robertson St. Mayor DeHart stated 9 people signed a petition asking for the speed bump, 24 names were submitted on a petition that did not want the speed bump, but 9 of those names do not live on Robertson St. Robertson Rd. sign needs to read Robertson St. Stop sign is to high and speed limit signs need to be addressed. Need to find out if street is in City Limits, City paid for repaving; warning signs have been ordered for this area, Mayor DeHart suggested rumble strips-snow plow can go over a rumble strip better than a recessed area. **Mayor DeHart asked for the opportunity to see if road is in the county, then City will either take out speed bump and install a rumble strip or a recessed area.**
9. Everyone is invited to an open house for Habitat for Humanity on Freeman Drive, Sunday December 16.
10. City Officials Academy will be held January 16-January 18 in Lexington. Will need to know by Monday if Council plans to attend.
