



February 10, 2011

The Russell Springs City Council held their regular monthly meeting this date at 6:00 p.m. at City Hall. 1. Mayor Hollis DeHart called the meeting to order.
2. **Ricky Barnes made the motion to accept the January 13 minutes. Lisa Mann seconded the motion. Motion carried 6-0.**
3. **Timmy Hudson made the motion to pay the bills. Eddie Thomas seconded the motion. Motion carried 6-0.**
4. Mayor DeHart informed the Council as soon as weather permits the brick for the Star Theater will be power washed. Sponsorship levels and ads were reviewed; **Eddie Thomas made the motion to do an Inside Front Cover Color--\$500 ad. Eric Selby seconded the motion. Motion carried 6-0.**

7. Ms. Clarissa Hart with the Lake Cumberland Area Development District invited all Council members, Mayor and City Clerk to an informative meeting on February 24, 2011 starting at 4:30 p.m.
8. Mr. Chris Ramsey with the County Judge's Office invited the Council, Mayor and all in attendance to the Grand Opening of the new Russell County Jail at 4:00 p.m. Friday February 11, 2011.
9. Mayor DeHart requested that each Council member review the projected employer contribution rates to the County Employees Retirement System (CERS) provided by the Kentucky League of Cities.
10. Officer Chasity Shirley with the RSPD showed the Mayor and Council the Facebook page for the Russell Springs Police Department with several charts on collisions, months with collisions, days with collisions, times of collisions, etc.
11. Eric Selby commended the Road Crew for the City, County and State with the amount of snow we have had.
