

March 11, 2010

The Russell Springs City Council held their regular monthly meeting this date at 6:00 p.m. at City Hall. 1. Mayor Hollis DeHart called the meeting to order.
2. **David Blakey made the motion to accept the February 11 special called meeting minutes and the February 11 regular meeting minutes. Ricky Barnes seconded the motion. Motion carried 6-0.**
3. **Timmy Hudson made the motion to pay the bills. David Blakey seconded the motion. Motion carried 6-0.**
4. Mayor DeHart informed the Council and the audience that this was the first meeting in the New City Hall which would house all departments. We now have a drive-through window to pay bills along with coming inside. With some outstanding bills yet to be paid the costs of the building will be approximately \$43.00 per square foot instead of the original costs of \$60.00 per square foot. Blacktopping and awnings are left to be installed. Open house will be late April or early May. Mayor DeHart thanked the Council members for great leadership and support throughout this project. He also thanked Jeramy Coffey, Scottie Redmon, Mark Barnett, Orby Popplewell, Brian Stephens, Richard Roy, Ronnie Jackson, Terry Russell, Allen McQueary, Leslie Simpson, Larry Phillips, Barry Grider, Mark McClure, Roger Redmon, Wendy Burton, Wanda Burton, Sharon Hill and Betty Wheat along with the Police Department.
5. The Council heard the 2nd reading of Ordinance 2010-01 a Supplement to the Code of Ordinances. **Ray Barrett made the motion to accept Ordinance 2010-01 Supplement to the Code of Ordinances. David Blakey seconded the motion. Motion carried 6-0.**
6. The Russell County High School Y Club members Trey Taylor, Kaitlin Blakey, Emily Adams, Cassandra Conner and Alex Hoover presented a program to the City Council. Trey Taylor expressed gratitude for being allowed to present their program. Cassandra Conner informed the Council the trip would consist of eight days travel across Kentucky repairing buildings, removing harmful plants, working with children. The group must raise \$2,500 and have 250 hours of service. Mayor DeHart saluted the students present. **Ray Barrett made the motion to give the students of the Y Club \$1500.00 for their trip. Timmy Hudson seconded the motion. Motion carried 6-0.**
7. **David Blakey made the motion to continue the Monumental Accidental Insurance for all volunteer firemen. Eric Selby seconded the motion. Motion carried 6-0.**

8. The Council heard the 1st reading of Ordinance 2010-02 Repealing Ordinance 2002-14.
9. The Council heard the 1st reading of Ordinance 2010-03 Creation of a Code Enforcement Board. The Code Enforcement Board will consist of three members.
10. David Blakey asked regarding the garbage on Bernard Lane. Mayor DeHart stated that since City Hall was finished, garbage pickup on city streets would now resume.
11. **Eric Selby and Council thanked Mayor DeHart for his time and dedication to the building of the New City Hall.**
12. **Ray Barrett made the motion to adjourn. David Blakey seconded the motion. Motion carried 6-0.**
