


June 8, 2017

PRAYER WAS SAID BY TIMMY HUDSON.

1. Mayor Eric Selby called the meeting to order.
2. **Larry Skaggs made the motion to accept the June 6 minutes. Timmy Hudson seconded the motion. Motion carried 6-0.**
3. **Eddie Thomas made the motion to pay the bills. Sherry Daniel seconded the motion. Motion carried 6-0.**
4. The Council heard the 2nd Reading of Amended Budget Ordinance 2017-03. **David Blakey made the motion to accept the 2nd reading of Amended Budget Ordinance 2017-03. Eddie Thomas seconded the motion. Roll Call vote with Ms. Daniel-yes; Mr. Thomas-yes; Mr. Skaggs-yes; Mr. Blakey-yes; Mr. Hudson-yes; Mr. Barnes-yes. Motion carried 6-0.**
5. Cheryl Adams came before the Council to introduce ArtWorks Community Arts Education Center. Ribbon cutting will be June 9 at 10:00 a.m. Ms. Adams purchased the old Guthrie building in Jamestown and has remodeled most of the building using approximately \$90,000 of her money and products from Russell County. Weekly fee for summer camp is \$125.00. Donations are for scholarships for needy children who cannot afford to attend. **Timmy Hudson made the motion to donate \$1,000.00 to ArtWorks Community Arts Education Center. Eddie Thomas seconded the motion. Motion carried 6-0.**
6. **Larry Skaggs made the motion to donate \$3,000.00 to the Russell County Laker Band. Eddie Thomas seconded the motion. Motion carried 6-0.**
7. City Attorney Matthew DeHart read The Interlocal Agreement between City of Russell Springs & Russell County Magisterial District 5. **Ricky Barnes made the motion to accept the Interlocal Road Agreement between City of Russell Springs & Russell County Magisterial District 5. Timmy Hudson seconded the motion. Motion carried 6-0.**
8. **Larry Skaggs made the motion at 6:34 p.m. to enter into executive session pursuant to KRS 61.810 1 (b) Deliberations on the future acquisition or sale of real property by a public agency, but only when publicity would be likely to affect the value of a specific piece of property to be acquired for public use or sold by a public agency. Timmy Hudson seconded the motion. Motion carried 6-0.**
9. **Sherry Daniel made the motion at 7:17 p.m. to reconvene from executive session. Eddie Thomas seconded the motion. Motion carried 6-0.**
