

1. Mayor Eric Selby called the meeting to order.
2. **Eddie Thomas made the motion to accept the May 12 minutes. Ricky Barnes seconded the motion. Motion carried 6-0.** Eddie Thomas stated that Kevin Williams Hometown Celebration exceeded their goal of \$30,000 this year.
3. **Tommy Holt made the motion to pay the bills. Timmy Hudson seconded the motion. Motion carried 6-0.**
4. Sherry Daniel asked regarding Arik Lane: Mayor Selby stated the City and the County would look into blacktopping this road and would share the expense.
5. Tommy Holt stated the Chalybeate Park looks good; with new benches, trash container has been ordered and landscaping will take place soon.
6. The Council heard the 2nd reading of Amended Budget Ordinance 2016-04. **Ricky Barnes made the motion to accept the Amended Budget Ordinance 2016-04. Sherry Daniel seconded the motion. Roll Call vote with Mr. Holt-yes, Mr. Hudson-yes, Mr. Thomas-yes, Mr. Barnes-yes, Ms. Daniel-yes, Mr. Blakey-yes. Motion carried 6-0.**
7. The Council heard the 2nd reading of Amendments to the City's Alcohol Beverage Control Ordinance 2016-05. Mayor Selby stated a lengthy discussion was held last month from both sides. Keith Taylor-Price Less Foods- Sunday Sales would increase sales, not personal just business: Danny Smith-Kroger-Businesses would benefit along with tourists coming to Lake Cumberland: Roy Patel-Shell-a lot of requests for Sunday Sales, would definitely help business; Bro. Jim Kingrey-Church has Celebrate Recovery-very successful program, relapse can and does happen with accessibility, encouraged a no vote: Jerry Burchett stated Sunday is the Lord's Day; Charles Gossett stated the County had never been dry-no one makes anybody drink, if drinks are bought here, then revenue is here, if drinks are bought elsewhere, then revenue is outside of our City. **Tommy Holt made the motion to accept Ordinance 2016-05 Amendments to the City's Alcohol Beverage Control Ordinance. David Blakey seconded the motion. Roll call vote with Mr. Blakey-yes --"As an elected official of the City and with the City's best interest at heart, that is why I vote yes"; Ms. Daniel-no-"I have friends on both sides, I am for progress and growth, Sunday Sales wasn't on the table, was told restaurants and businesses would come, I have to stand up for what God leads me to do"; Mr. Barnes-no; Mr. Thomas-no-" I am a recovering drug addict and nobody forced me to do it, but by the Grace of God I can't vote for it"; Mr. Hudson-no-" I have prayed about this, rededicated my life twenty four years ago, been both the Sinner and the Christian, that is why I vote no"; Mr. Holt-yes-" I have listened to constituents and**

- businesses owners, took a poll on FB, countless calls, letters, father was an alcoholic in a dry county, but I have to vote yes". Motion failed with 4 no votes and 2 yes votes.
8. David Blakey made the motion to adjourn. Tommy Holt seconded the motion. Motion carried 6-0.
