August 12, 2010

The Russell Springs City Council held their regular monthly meeting this date at City Hall at 6:00 p.m. In attendance were Joey Hoover, Ramie Hutchinson, Derek Aaron, John Thompson, Joe Irvin, Jeramy Coffey, Athena Cooper, Timmy Hudson, David Blakey, Eric Selby, Ricky Barnes, Lisa Mann, Ray Barrett, Hollis DeHart and Wanda Burton.

- 1. Mayor Hollis DeHart called the meeting to order.
- 2. Lisa Mann made the motion to accept the minutes of July 8. Ricky Barnes seconded the motion. Motion carried 6-0.
- 3. Lisa Mann made the motion to pay the bills. Ray Barrett seconded the motion. Motion carried 6-0.
- 4. Mayor DeHart informed the Council that Robertson Road around to Butler Drive from Hwy 80 had been blacktopped. The work is completed and a nice job. The committee had reported problems with Alexander Street which is on schedule to be fixed. Tree limbs & blind places also on Alexander. Apache has a rough entrance, needing to take paving machine over to take care of that problem. Barrett suggested Comanche Way to Kingfisher Lane. Also a few roads that need to be patched were Jewell Street, Gentry Mill, Emerson, Creelsboro and a few off of Campground Road in that area.
- 5. Mayor DeHart informed the Council he had met with Hospital concerning a right of way coming off of Joe Petty Drive that the city owns. Had once been a right of way going into a subdivision about 31-32 feet wide. The hospital needing that area for parking lot in new renovation. Would leave out part of curb and give us entry way to water tower. Mayor DeHart felt it would be appropriate for the city to make a deed to the hospital. Motion made by Timmy Hudson to let the hospital have the lot with us an easement to water tower. David Blakey seconded the motion. Motion carried 6-0.
- 6. The Russell County Fiscal Court is going to run a four foot woven wire fence on the backside of jail property on northern side up to branch area of the senior citizen. At some point of time when bulldozing was being done, something happened to about 300 feet of fence that is on city line joining Illa Knight going up to corner of Daryl Coe. Fiscal Court took bids on their part of fence. The bid they accepted was from F & C Fencing at a cost of \$2.35 a foot. Ray Barrett made the motion to erect the fence. Eric Selby seconded the motion. Motion carried 6-0.
- 7. David Blakey said he had been questioned about the gas for city vehicles. Jeramy Coffey explained to him the city is set up with Wright Credit Cards and that they could be used anywhere in city that accepts these cards. This company gives a monthly report on each individual vehicle.

8. Ricky Barnes made the motion to adjourn. Timmy Hudson seconded the motion. Motion carried 6-0.
