
The Russell Springs City Commission held their regular monthly meeting this date at City Hall at 6:00 p.m. In attendance were Eric West, Ramie Hutchison, Jeramy Coffey, Richard Roy, Jeanne Hudson, Brittany Emerson, Derek Aaron, Joey Hoover, Claradon Wilson, James Faller, Joe Irvin, Matthew DeHart, Ray Barrett, Wayne Gaskins, Timmy Hudson, Richard Wooldridge, Don Byrom, Hollis DeHart and Wendy Burton.

1. Mayor Hollis DeHart called the meeting to order.
2. **Richard Wooldridge made the motion to accept the minutes of July 18 as written. Wayne Gaskins seconded the motion. Motion carried 5-0.**
3. **Timmy Hudson made the motion to pay the bills. Wayne Gaskins seconded the motion. Motion carried 5-0.**
4. The Commission heard the 2nd reading of Ordinance 2008-07 relating to the Occupational License Tax. **Ray Barrett made the motion to accept Ordinance 2008-07 as written. Richard Wooldridge seconded the motion. Motion carried 5-0.**
5. The Commission heard the reading of Municipal Order 2008-01 updating Police Department Operating Procedures. **Richard Wooldridge made the motion to accept Municipal Order 2008-01 as written. Ray Barrett seconded the motion. Motion carried 5-0.**
6. Mayor DeHart commented on the Fire Subscription Service-most households within the designated area received a letter along with a map; costs under 3,000 square feet \$35; over 3,000 square feet \$50; commercial \$100. All the Russell Springs Firefighters are volunteers who place their lives on the line during each incident. Members are exempt from costs; non members will be responsible for payment if called.
7. Timmy Hudson stated the Fire Dept. had not been very busy; three (3) working on certifications.
8. Richard Wooldridge stated twelve water taps had been made. New sewer project is now available from: Highway 80 from Owenstown to Fairview; Highway 910 from Fairview to Salem Church; Highway 76 from Salem Church to Alligator 1; Highway 1383 to Alligator 2; Cabin Drive; Horseshoe Dr. These tap fees are \$350 each and requires a grinder station which varies in price. Gravity sewer lines are on Autumn Drive; Stonebrook; Jessie Way and Brady Lane; again tap on fees are \$350. Contact person is Terry Russell.
9. Ray Barrett informed the Commission the new pool hours are Monday – Friday 1:00p.m. - 7:00 p.m. and regular hours on Saturday and Sunday. Pool will remain open until Labor Day. Butler Drive and Sambo Lane have received new blacktop.
10. Wayne Gaskins informed the Commission an officer resigned last month and applications will be accepted through September 1.
11. Mr. James Faller asked regarding annexation of his property. Mayor DeHart stated on the backburner; area marked but not in the very near future.

12. **Ray Barrett made the motion to adjourn. Timmy Hudson seconded the motion. Motion carried 5-0.**
