



September 12, 2013

The Russell Springs City Council held their regular monthly meeting this date at City Hall at 6:00 p.m. In attendance were Ramie Hutchison, Jim Lien, Carroll Egnew, Derek Aaron, Joe Irvin, David Blakey, Lisa Mann, Ricky Barnes, Timmy Hudson, Joshua Robertson, Eddie Thomas, Matthew DeHart, Eric Selby and Wendy Burton.

Brother Carroll Egnew said the prayer.

1. Mayor Eric Selby called the meeting to order.
2. **David Blakey made the motion to accept the August 8 minutes. Timmy Hudson seconded the motion. Motion carried 6-0.**
3. **Lisa Mann made the motion to pay the bills. Ricky Barnes seconded the motion. Motion carried 6-0.**
4. **Lisa Mann made the motion to accept the 2013-2014 Interlocal E-911 Agreement. David Blakey seconded the motion. Roll call vote, Mr. Hudson-yes, Mr. Robertson-yes, Mr. Thomas-yes, Mr. Barnes-yes, Ms. Mann-yes, Mr. Blakey-yes. Motion carried 6-0.**
5. Resolution 2013-07, the City of Russell Springs will receive grant funds from the KEDFA for the Russell County Industrial Development Authority. **Eddie Thomas made the motion to accept Resolution 2013-07. Timmy Hudson seconded the motion. Motion carried 6-0.**
6. The Council heard the 1st reading of Ad Valorem Tax Ordinance 13-07.
7. Resolution 2013-08 authorizing the Mayor of the City of Russell Springs to negotiate and execute any and all documents which he deems necessary for any projects with the Department of Transportation. **Ricky Barnes made the motion to accept Resolution 2013-08. Lisa Mann seconded the motion. Roll call vote, Mr. Blakey-yes, Ms. Mann-yes, Mr. Barnes-yes, Mr. Thomas-yes, Mr. Robertson-yes, Mr. Hudson-yes. Motion carried 6-0.**
8. David Blakey asked regarding the 2013 Property Tax Rate? Mayor Selby stated if passed, tax rate would be .170 per \$100. 2012 rate was .167. On a \$65,000 home, 2013 taxes would be \$110.50, 2012-108.55. The tangible assessments were decreased by approximately three million dollars this year.
9. David Blakey commended Downtown Revitalization for a good festival.
10. **David Blakey made the motion to adjourn. Joshua Robertson seconded the motion. Motion carried 6-0.**
