1. Mayor Eric Selby called the meeting to order.
2. **Eddie Thomas made the motion to accept the August 11 minutes. Sherry Daniel seconded the motion. Motion carried 6-0.**
3. **David Blakey made the motion to pay the bills. Sherry Daniel seconded the motion. Motion carried 6-0.**
4. Blake and Brett Aaron with Aaron Outdoors seeking advertisers/sponsors for their new season on the Hunt Channel on Dish Network; will reach 30,000,000 homes; Russell Springs is the "Gateway to Lake Cumberland"; they do their own commercials. **Eddie Thomas made the motion to do a Bronze Sponsorship at \$1,000.
