## Schedule F Monthly Regulatory Fee<sup>2</sup> Instructions

- 1. Calculate total <u>GrossReceiptsfromFoodSales.</u> Enter amount on (Line 1).
- 2. Calculate total <u>Gross Receipts for sale of Alcoholic Beverages</u> of each license issued by the ABC Administrator. Enter amount on (Line 2).
- 3. <u>Regulatory Fee</u>: Calculate 6% of amount entered for Gross Receipts for sale of Alcoholic Beverages by the Drink on (Line 2), enter result on (Line 3).
- 4. <u>Monthly License Fee Credit:</u> License fee will be deducted from regulatory fee until all credit is taken, enter amount (Line 4).
- 5. Enter amount of calculation of <u>Regulatory Fee</u> (Line 3) less monthly Credit (Line 4) on (Line 5).
- 6. <u>Penalty for Late Payment</u>: Failure to file a return and pay monthly remittance by the due date is to be calculated at five percent (5%) of the regulatory fee(s) due (Line 5) for each ninety (90) days or fraction thereof. The total late filing penalty shall not exceed twenty-five percent (25%) of the regulatory fee due (Line 5); provided however, that in no case shall the penalty be less than 10 dollars (\$10.00). Enter amount on (Line 6).
- 7. <u>Interest for Late Payment:</u> Calculate Interest at the rate of eight percent (8%) per annum. This will apply to any late payments of regulatory fee due (Line 5). Enter amount on (Line 7).
- 8. <u>Total Regulatory Fee Due:</u> Calculate Subtotal Regulatory Fee Due (Line 5), Penalty for Late Payment (Line 6), and Interest for Late Payment (Line 7) and enter amount on (Line 8).
