RUSSELL SPRINGS CITY COUNCIL MEETING REGULAR MEETING THURSDAY, MAY 10, 2018 6:00 P.M.

The Russell Springs City Council held their regular monthly meeting on Thursday, May 10, 2018 at 6:00 p.m., in the Council Room at Russell Springs City Hall. Those in attendance were Mayor Eric Selby, Council Members David Blakey, Timothy Hudson, Eddie Thomas, Ricky Barnes, Sherry Daniel, Larry Skaggs, City Attorney Matthew DeHart, Police Chief Joe Michael Irvin, ABC Investigator Brian Stephens, and City Clerk Christopher Ramsey.

Opening prayer was led by Councilman Thomas.

WELCOME: Mayor Selby called the meeting to order and welcomed all those present.

MINUTES: Mayor Selby presented the minutes from the regular meeting held on April 12th, and special called meetings held on April 19th. Councilman Blakey made a motion to approve the minutes with Councilman Hudson seconding. The vote was unanimous.

PAY BILLS: Mayor Selby submitted a list of regular bills to be approved. Councilman Barnes made a motion to pay the bills with Councilman Blakey seconding. The vote was unanimous.

HWY 127 Fence Removal: Councilman Skaggs asked for an update on the project. With Mr. Jeramy Coffey not being present, Mayor Selby gave an update to the council and let them know the markers have been ordered. At present, the city is waiting on the KY Hwy Department to give the final go ahead.

City Water Line Repair: Councilwoman Daniel asked for an update or cost for replacing several waterlines close to Shepherd Drive. Mayor Selby said that Terry Russell is currently working with our engineers to come up with those figures.

AWARD CITY SCHOLORSHIPS: Received 14 applications, with three of the council members reviewed all of the applications and recommenced their selections to Mayor Selby. Mayor Selby will be announcing those winners at the upcoming awards ceremony at the high school.

ROAD REPAIR: Councilwoman Daniel and Councilman Hudson requested that Judy Drive be repaired. Mayor Selby said he would follow up on that road.

ROAD AID AGREEMENT – RESOLUTION 2018-01: City Clerk Ramsey read Resolution 2018-01. Councilman Skaggs made a motion to except Resolution 2018-01 with Councilwoman Daniels seconding. Vote was unanimous 6-0.

COUNCILWOMAN DANIEL: Ms. Daniel complemented Brian Stephens for a job well done handling some code enforcement issues.

BUDGET UPDATE: Mayor Selby requested that each council member come to city hall to meet with Mr. Ramsey to discuss the upcoming budget. Mayor Selby said to plan on having a special called meeting June 7th for a first reading of the 2018-2019 budget and the 2017-2018 amended budget. The second readings will be at the regular monthly meeting on June 14, 2018.

ADJOURNMENT: Councilman Skaggs made a motion to adjourn the meeting with Councilman Thomas seconding. All was in favor.
