

RUSSELL SPRINGS CITY COUNCIL MEETING  
REGULAR MEETING

The Russell Springs City Council held their regular monthly meeting on Thursday, January 10, 2019 at 6:00 p.m., in the Council Room at Russell Springs City Hall. **WELCOME:** Mayor Thomas called the meeting to order and welcomed all those present.

**MINUTES:** Mayor Thomas presented the minutes from the regular meeting held on December 13th. **Councilman Skaggs made a motion to approve the minutes with Council Blake seconding. The vote was unanimous.**

**CASH DISBURSEMENTS & FINANCIAL STATEMENTS:** Mayor Thomas submitted cash disbursements and financial statements to be approved. **Councilwoman Daniel made a motion to accept the cash disbursements and financial statements with Councilman Blake seconding. The vote was unanimous.**

**127 FENCE UPDATE:** Councilman Skaggs asked for an update of the fence project. Mr. Coffey stated that the project is 90-95% complete.

**TRANSFER OF ABC FUNDS:** Councilwoman Daniel made a motion to transfer ABC funds from First National Bank to Citizens National Bank with Councilman Blakey seconding. **Motion Carried 6-0.**

**POLICE ROSTER:** Mayor Thomas thanked Police Chief Irvin and his department for their dedication and sacrifice to the City of Russell Springs.

**ABC INVESTIGATOR:** Mayor Thomas informed the council that he had appointed City Clerk Christopher Ramsey to also serve as ABC Investigator.

**MAYOR'S ECONOMIC UPDATE:** The owners of the new five star gas station has recently let Mayor Thomas know they plan on opening at the first of Spring. Little Caesars Pizza is now open for business in their new location. Active Day Care location has a goal of opening the first week of April.

**KLC Award:** Mayor Thomas presented Councilwoman Daniel an award from KLC for completing level one training hours.
