## ORDINANCE NO.\_\_\_\_\_.

AN ORDINANCE PROVIDING FOR AND LEVYING A YEARLY LICENSE TAX UPON CERTAIN BUSINESS—ES, OCCUPATIONS AND PROFESSIONS IN THE TOWN OF RUSSELL SPRINGS, KENTUCKY, PROVIDING FOR THE LICENSING OF SUCH BUSINESSES, OCCUPATIONS AND PROFESSIONS, AND MAKING IT A MISDELEANOR FOR ANY PERSON, FIRM OR CORPORATION TO ENGAGE IN OR FOLLOW ANY OF SAME WITHOUT FIRST OBTAINING A LICENSE SO TO DO, AND PROVIDING A PENALTY FOR THE BREACH OF ANY OF THE PROVISIONS OF THIS ORDINANCE.

The Board of Trustees of the Town of Russell Springs, Kentucky, DO ORDAIN AS FOLLOWS:

SECTION ONE. There shall be and there is hereby levied a yearly license tax in the hereinafter set forth amounts upon the hereinafter set forth business, occupations and professions in the Town of Russell Springs, Kentucky, to-wit:

SECTION TWO. No person, firm or corporation shall maintain, engage in, carry on or follow any of the businesses, occupations or professions named in Section One hereof in the Town of Russell Springs, Kentucky, without first obtaining a license so to do from the Clerk of said town and paying the said yearly license hereby levied upon such business, occupation or profession, but it is hereby expressly provided that, at the option of the holder of such license, said yearly license tax may be paid in a lump sum upon obtaining such license, or same may be paid to The Town Marshall of Said Town in equal monthly installments of an amount equal to one-twelfth (1/12) part of said yearly tax, each of said installments following the first to be paid on or before the first day of each calendar month following the expiration of the calendar month in which such license is issued while such license is in force or effect, or until the full amount of such yearly tax is paid.

The Town Clerk of said town is hereby authorized and directed to issue the licenses herein provided for upon application and the payment to him of either the full amount of the yearly license tax hereby levied upon the business, occupation or profession for which a license, is sought, or of the payment to him of one monthly installment of such yearly tax as above provided for, either of said payments to be made at the option of the license as aforesaid.

Any license issued hereunder shall be and become null, void and of no effect immediately upon the failure of the holder hereof to pay the yearly license tax, or any installment thereof, hereby levied upon the business, occupation or profession for which such license is obtained, and all licenses issued hereunder shall be and become null, void and of no effect at the expiration of one year from the respective dates of their issuance.

SECTION THREE. Any breach of any of the provisions of this ordinance shall be deemed a misdemeanor, and, upon conviction in the Police Court of Russell Springs, Kentucky, any person, firm, or corporation so offending shall be punished by a fine of not less than \$1.00 nor more than \$16.00, or both so fined and imprisoned, and each day any person, firm or corporation shall engage in, carry one, or follow any of the businesses, occupations or professions upon which a license tax is hereby levied without being licensed so to do, as herein provided, shall be deemed a separate offense.

SECTION FOUR. All ordinances, resolutions, orders, or parts of same in conflict herewith are to the extent of such conflict hereby repealed, and this ordinance shall be and become in full force and effect immediately upon its adoption, approval and publication as required by law.
