

RUSSELL SPRINGS CITY COUNCIL MEETING
SPECIAL CALLED MEETING
THURSDAY, JUNE 25, 2020
6:00 P.M.

The Russell Springs City Council held their special called meeting on Thursday, June 25, 2020 at 6:00 p.m., in the Council Room at Russell Springs City Hall. Those in attendance were Mayor Eddie Thomas, Council Members Sherry Daniel, Tom Holt, Timmy Hudson, & David Blakey, Police Chief Joe Michael Irvin, and City Clerk Christopher Ramsey.

WELCOME: Mayor Thomas called the meeting to order and welcomed all those present. Mayor Thomas reminded those in attendance with it being a special called meeting only items on the agenda could be discussed.

ROLL CALL: Council Members in attendance, Mr. Blakey, Ms. Daniel, Mr. Holt, Mr. Hudson. Absent Mr. Barnes and Mr. Skaggs.

OPENING OF BIDS FOR FUEL, OIL, CHIP & SEAL, HOT MIX, BLACKTOP, POTHOLE PATCH, ROCK (ALL TYPES) AND TILE: Mayor Thomas asked Clerk Ramsey to open the bids received by his office before the deadline. Mr. Ramsey explained how the bids were requested in the Times Journal in accordance with state law. Mr. Ramsey also stated that only two bids were submitted. Mr. Ramsey opened the bids from Gaddie Shamrock and Selby Asphalt Maintenance, Inc. Gaddie Shamrock bid on Hot Mix hauled and laid in the City of Russell Springs for a bid price of \$77.00 based on the price index of \$432.86 per liquid ton. With every \$10.00 increase in the cost of liquid asphalt per ton over this amount, the base index bid will increase \$1.00 per ton. Selby Asphalt Maintenance, Inc. bid on all asphalt repairs, repair of cracks, rock & tile work, emergency storm debris removal & emergency road services, sealing, pavement markings, backhoe & skid steer services, and snow removal. Asphalt repair any and all areas will be prepped (dug out, cleaned out, and /or filled with gravel) by Selby Asphalt Maintenance. **Councilwoman Daniel made a motion to accept the bids submitted by Gaddie Shamrock and Selby Asphalt Maintenance with Councilman Hudson seconding. The vote was unanimous.**


MUNICIPAL ROAD AID PUBLIC COMMENT REPORT: Mayor Thomas asked Clerk Ramsey to inform the council about the Municipal Road Aid Public Comment period. Mr. Ramsey stated that the City had requested public comments or suggestions about the spending of the Road Aid monies during the 2020-2021 fiscal year. As required by law, Mr. Ramsey said the City did run a public notice ad in the Times Journal requesting public comments either at the hearing held earlier in the afternoon or by email. Mr. Ramsey reported that there were no public comments submitted either verbally or via email. the second reading of Ordinance 2020-03, this ordinance is sponsored by Councilman Hudson.

ANNUAL FIRE DUES: Mr. Ramsey let the council know that annual fire dues are due by July 31st for non-residents that do reside within the Russell Springs Fire District.

ADJOURNMENT: Councilman Holt made a motion to adjourn the meeting with Councilwoman Daniel seconding. The vote was unanimous.
