The Russell Springs City Council held their regular monthly meeting on Thursday, June 10, 2021, at 6:00 p.m., in the Council Room at Russell Springs City Hall. WELCOME: Mayor Thomas called the meeting to order and welcomed all those present.

**ROLL CALL:** City Clerk Christopher Ramsey performed the roll call. Council Members in attendance, Mr. Holt, Mr. Blakey, Ms. Daniel, Mr. Hudson, Mr. Barnes and Mr. Skaggs.

MINUTES: Mayor Thomas presented the minutes from the regular meeting on May 10<sup>th</sup>. Councilwoman Daniel made a motion to approve the minutes with Councilman Blakey seconding. Motion Carried. The vote was unanimous.

FIRST READING OF ORDINANCE 2021-02 – AMENDED ORDINANCE FOR ANNUAL BUDGET – FISCAL YEAR 2020-2021: Clerk Ramsey performed the first reading of Ordinance 2021-02 in its entirety. Ordinance 2021-02 is sponsored by Councilwoman Daniel.

Councilman Holt thanked Mayor Thomas, Mr. Ramsey, and all department heads for being good stewards of the City's monies and keep up the good work.

## **MAYOR'S UPDATE:**

The property beside of the Russell Springs Cemetery has now been torn down and that will complete phase one of the revitalization of the cemetery property. Phase two will be announced shortly.
