SPECIAL CALLED REGULAR MEETING
MONDAY, JUNE 27, 2022

The Russell Springs City Council held their special called meeting on Monday, June 27, 2022, at 8:00 a.m., in the Council Room at Russell Springs City Hall. WELCOME: Mayor Thomas called the meeting to order and welcomed everyone with a reminder only items on the agenda maybe discussed.

ROLL CALL: City Clerk Christopher Ramsey performed the roll call. Council Members Present: Mr. Barnes, Mr. Hudson, Mr. Holt, Ms. Daniel, Mr. Blakey, and Mr. Skaggs.

RESOLUTION 2022-04: A RESOLUTION RELATING TO THE AMERICAN RESCUE PLAN ACT (ARPA), AUTHORIZING PREMIUM PAY FOR ESSENTIAL CITY OF RUSSELL SPRINGS GOVERNMENT WORKERS: Mayor Thomas called on Clerk Ramsey to read Resolution 2022-04. **Councilman Hudson made a motion to accept Resolution 2022-04 as presented with Councilwoman Daniel seconding. Motion Carried. The vote was unanimous.**

SECOND READING ORDINANCE 2022-03 – ORDINANCE FOR ANNUAL BUDGET – FISCAL YEAR 2022-2023 SPONSORED BY COUNCILMAN SKAGGS: Clerk Ramsey performed the second reading of Ordinance 2022-03. Also, addressed in the budget is to keep the ABC Regulatory Fee at 6%. **Councilman Skaggs made a motion to accept Ordinance 2022-03 as presented with Councilman Hudson seconding. Motion Carried. The vote was unanimous.**

SECOND READING ORDINANCE 2022-04 – ORDINANCE FOR AMENDED ANNUAL BUDGET – FISCAL YEAR 2021-2022 SPONSORED BY COUNCILWOMAN DANIEL: Clerk Ramsey performed the second reading of Ordinance 2022-04. **Councilman Blakey made a motion to accept Ordinance 2022-04 as presented with Councilwoman Daniel seconding. Motion Carried. The vote was unanimous.**
