

RUSSELL SPRINGS CITY COUNCIL MEETING  
SPECIAL CALLED REGULAR MEETING

The Russell Springs City Council held a special called meeting on Friday, October 20, 2023, at 8:00 a.m., in the Council Room at Russell Springs City Hall. 
**SECOND READING OF ORDINANCE 2023-09: AN ORDINANCE ADOPTING PAY STRUCTURES FOR CITY BOARDS: CEMETERY BOARD, CODE ENFORCEMENT BOARD, ZONING & PLANNING BOARD, AND BOARD OF ADJUSTMENTS (SPONSORED BY COUNCILMAN BARNES):** Clerk Ramsey provided the second reading of Ordinance 2023-09. **Councilwoman Mann made a motion to accept Municipal Order 2023-09 as presented with Councilwoman Daniel seconding. Motion Carried. The vote was unanimous.**

**SECOND READING OF ORDINANCE 2023-10 – AD VALOREM TAX 2023 (SPONSORED BY COUNCILMAN WILSON):** Clerk Ramsey provided the second reading of Ordinance 2023-09. Mayor Thomas stated that if passed, the City Property tax rate would go down. **Councilwoman Daniel made a motion to accept Ordinance 2023-10 with Councilman Wilson seconding. Motion Carried. The vote was unanimous.**

**ACCEPT OR REJECT PROPOSED ZONING CHANGE – 2043 STEVE WARINER DRIVE FROM R-1 TO R-4:** Mr. Holt presented the proposed change to the council. Again, Mr. Holt reminded the council that the Zoning and Planning Board had passed on this issue. Property owner, Mr. Cody Coffey was present at the meeting and presented what plans he has in place for the property. **Councilman Barnes made a motion to accept the proposed zoning change for 2043 Steve Wariner Drive with Councilman Blakey seconding. Roll Call: Yes: Blakey, Barnes. No: Mann, Wilson, Daniel. Motion Failed**


**ADJOURNMENT:** Councilman Blakey made a motion to adjourn the meeting with Councilman Wilson seconding. All was in favor.
