

RUSSELL SPRINGS CITY COUNCIL MEETING
SPECIAL CALLED MEETING
THURSDAY, MAY 30, 2024
7:30 A.M.

The Russell Springs City Council held a special called meeting on Thursday, May 30, 2024, at 7:30 a.m., in the Council Room at Russell Springs City Hall. Those in attendance were Mayor Eddie Thomas; Council Members: Ricky Barnes, Timmy Hudson, David Blakey, Cody Wilson, Sherry Daniel, and Lisa Mann, Police Chief Bryan Shepard, Director of Facilities & Maintenance Brian Stephens, Zoning Administrator Tom Holt, and City Clerk Christopher Ramsey.

WELCOME: Mayor Thomas called the meeting to order and welcomed everyone.

RESOLUTION 2024-09: LAND AND WATER CONSERVATION FUND GRANT – Clerk Ramsey read the entire resolution. **Councilman Barnes made a motion to approve Resolution 2024-09 as presented, with Councilman Hudson seconding. Motion Carried. The vote was unanimous.**

RATIFICATION OF ZONING CHANGE: 425 JAMESTOWN STREET FROM C-1 TO R-4: Mayor Thomas asked Mr. Holt to speak on the zoning change. **Councilman Hudson made a motion to accept the zoning change passed by the Zoning and Planning Board, with Councilman Barnes seconding. Voting yes: Barnes, Blakey, Hudson. Voting no: Wilson, Mann, Daniel. With it being a tied vote, Mayor Thomas voted and broke the tie in favor of the change. Motion Carried 4-3.**

RATIFICATION OF ZONING CHANGE: 30 COFFEY AVENUE FROM R-1 TO R-2: Mayor Thomas asked Mr. Holt to speak on the zoning change. **Councilwoman Daniel made a motion to accept the zoning change passed by the Zoning and Planning Board, with Councilwoman Mann seconding. Motion Carried. The vote was unanimous.**

RATIFICATION OF ZONING CHANGE: 2043 WEST HWY 80 FROM R-1 TO R-4: Mayor Thomas asked Mr. Holt to speak on the zoning change. **Councilman Barnes made a motion to accept the zoning change passed by the Zoning and Planning Board, with Councilman Blakey seconding. Voting yes: Barnes, Blakey, Hudson. Voting no: Wilson, Mann, Daniel. With it being a tied vote, Mayor Thomas voted and broke the tie in favor of the change. Motion Carried 4-3.**

ADJOURNMENT: Councilman Blakey moved to adjourn the meeting, with Councilman Wilson seconding. Unanimous. Motion Carried.
