

RUSSELL SPRINGS CITY COUNCIL MEETING  
SPECIAL CALLED MEETING

The Russell Springs City Council held a special-called meeting on Monday, June 2, 2025, at 7:00 a.m., in the Council Room at Russell Springs City Hall. Those in attendance were Mayor Eddie Thomas; Council Members: Timmy Hudson, Sherry Daniel, Ricky Barnes, and Gary Frost; Police Chief Bryan Shepard, Economic Development Director Jeramy Coffey, Zoning Administrator Tommy Holt, City Attorney David Smith, Director of Maintenance & Facilities Brian Stephens, and City Clerk Christopher Ramsey.

**WELCOME:** Mayor Thomas called the meeting to order and welcomed everyone.

**ROLL CALL:** City Clerk Christopher Ramsey performed the roll call. Present: Mr. Frost, Mr. Barnes, Ms. Daniel, and Mr. Hudson.

**SECOND READING OF ORDINANCE 2025-04: AN AMENDMENT TO MUNICIPAL ORDER 2024-04 AN ORDINANCE FINALLY ANNEXING AN AREA OF PROPERTY SOUTH OF FRENCH VALLEY ROAD AND WEST OF THE EXISTING RUSSELL SPRINGS BOUNDARY A/K/A "REXROAT HEIRS PROPERTY" (SPONSORED BY COUNCILMAN BARNES).** At Mayor Thomas' request, Clerk Ramsey presented the second reading of Ordinance 2025-04 to the City Council. **Councilman Barnes made a motion to adopt Ordinance 2025-04 as presented, with Councilman Huckaby seconding. **FIRST READ OF ORDINANCE 2025-08: AN ORDINANCE FINALLY ANNEXING AN AREA OF PROPERTY IN THE DEERFIELD ESTATES SUBDIVISION (SPONSORED BY COUNCILMAN HUCKABY):** At Mayor Thomas' request, Clerk Ramsey presented the first reading of Ordinance 2025-08 to the City Council.

**FIRST READ OF ORDINANCE 2025-09: AN ORDINANCE AMENDING THE ZONING CODE TO ESTABLISH A HOSPITAL-MEDICAL (H-M) ZONE AND TO DEFINE AND REGULATE ALCOHOL AND OTHER DRUG TREATMENT ENTITIES (AODEs) (SPONSORED BY COUNCILMAN HUDSON):** At Mayor Thomas' request, City Attorney Smith presented the first reading of Ordinance 2025-09 to the City Council.
